<p>This helps us quickly contact the correct insurance plan and obtain a timely authorization for your patient's exam.</p>	<p>Having chart notes available to submit with the request for authorization helps speed the process along. Providing the information below by fax, phone or secure email will help expedite pre-authorization:</p> <ul style="list-style-type: none"> • Current signs and physical exam findings • Specific injury or trauma (if applicable) • Physical therapy and how long (if applicable) • Any past diagnostic imaging related to the body part being imaged (reports and images) • Any medications the patient is taking 	<p>An ICD-10 diagnosis code is preferred by most insurance companies, if available. A general diagnosis, such as knee pain or other symptoms, or a rule out, is useful if the ICD-10 is not available.</p>

*Note that authorizations will only be provided when permitted by the patient's payer. **Some payers may require additional information. ***NOTE ON STAT AUTHS: Each insurance company defines the parameters of STAT differently. This may vary from 4 to 48 hours depending on the plan. RAYUS's insurance specialists will pursue authorization when clinical chart notes are provided. In some cases, the plan may require the referring provider to speak with the plan medical Director. In this instance, RAYUS will notify your office and ask that you complete the authorization process.
